

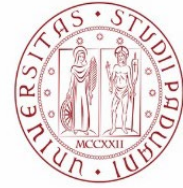

## Summer School Overview

The ESG movement has been a stone thrown into a pond, its ripples changing – even transforming – many aspects of our economy, our ways of living, and our collective future.

This Summer School program invites undergraduate and graduate students from Padova, as well as other universities in Italy and around the world, to learn how a new focus by business and finance on “environment, social and governance” (ESG) is affecting nearly all aspects of legal, as well as economics inquiries. Our world is in the process of transition, and private and public law are awakening to the epochal changes underway.

Professors and policy leaders from a range of disciplines will address these changes – from corporate governance and securities regulation, to bankruptcy and contract law, to banking and tax law, to innovation, IP, and administrative law, to environmental, criminal, and canon and ecclesiastical law.

This Summer School program arises out of a Sustainable Corporations Symposium co-organized in April 2021 by Professors Alan Palmiter (Wake Forest Law) and Maurizio Bianchini (Padova Law).

## Summer School Enrollment Details

The Summer School is open to all students matriculated in any undergraduate or postgraduate Law, Economics, Business Administration and Management, Political Science and International Relations at any Italian or foreign Academic Institution and, in particular:

- ◆ Undergraduate students enrolled in the Bachelor and Master's Degree Courses in Law, Economics, Political Science and International Relations;
- ◆ Undergraduate students enrolled in the three-years "Third Sector Law" Curriculum at the University of Padova School of Law;
- ◆ Post-Graduate and/or PhD students in Law, Economics, Business Administration and Management, Political Sciences and International Relations.

Please note that **all the Summer School lectures will be offered in person and online** (via Zoom platform).

Enrollment in the Summer School Program will start on **23 of August, 2022, at 3:00 pm CEST**, and it will end the **19 of September 2022**.

Please note that **attendance in person** is limited to a **maximum of 36 students** and in person enrollment will occur **on a first-come-first-served basis**. If you are planning on attending the Summer School **online (via Zoom)**, please note that you need first to enroll in the Summer School in order to have online access to the Summer School lectures. Instructions and access passwords will be provided to enrolled students shortly before the Summer School's inception date.

## Summer School Enrollment Details (continued)

Summer School Program enrollment shall occur by filling up the Padova [Summer School Enrollment Form](#) (please remember that students' enrollment starts at 3:00 pm CEST of the 23<sup>rd</sup> of August, and ends at 11:59 pm CEST of the 19<sup>th</sup> of September, 2022; and please remember to attach to the Form a scanned color copy of your University badge, or other official document showing your current student status). You should always use your own Academic Institution e-mail address when communicating with the Summer School.

Personal data of each student enrolling in the Summer School Program will be treated in accordance with applicable data privacy laws for purposes of processing each Summer School enrollment request by each filing student, checking and managing each enrolled student's attendance, issuing the Certificate of Attendance (if requested), as well as for statistical purposes.

Attendance to the Summer School is **free of charge**. However, students attending the Summer School in person are responsible for their own travel, board, and living expenses.

## Certificate of Attendance

Upon request, a Certificate of Attendance will be issued to every (undergraduate and post-graduate) student attending at least 80% of the Summer School lectures.

## Application for ECTS Credits Certificates<sup>(\*)</sup>

Non-Padova Students, who attended at least 80% of the Summer School lectures and upon positive accomplishment of the optional Summer School Final Written Assignment (as described *infra*) may apply for a Certificate of Summer School Completion attesting that, according to the University of Padova, the workload completed by the requesting student in connection with the Summer School, would be considered equivalent to 3 (three) ECTS.

## Summer School Final Written Assignment

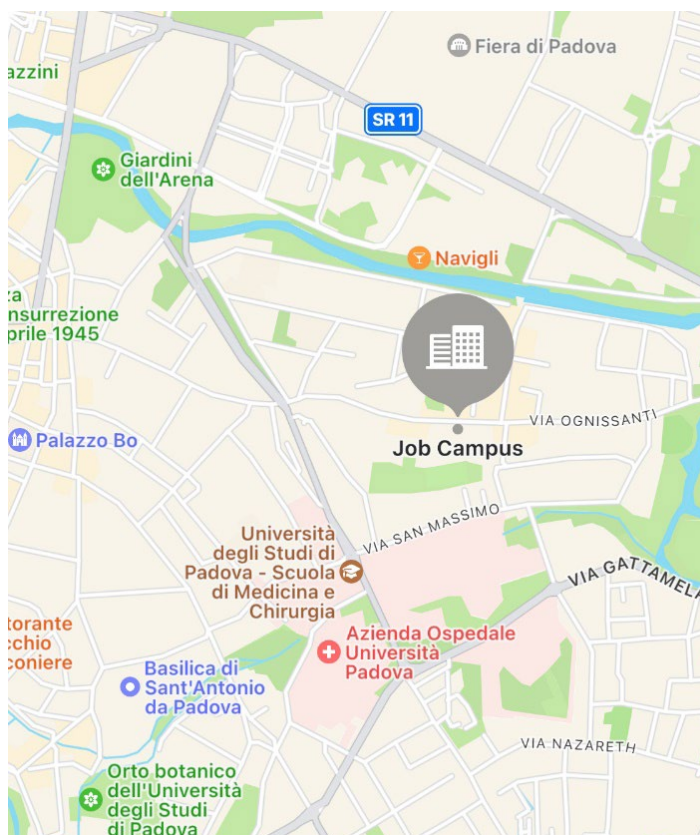
The Summer School Final Written Assignment is mandatory only for students seeking ECTS/CFU recognition. It consists in writing a Short Essay of at least 1800 words (excluding cover page, abstract, and bibliography) on a topic, to be chosen out of a list which will be provided to any students interested in attaining the ECTS (CFU) Credits during the Summer School week. The essay topics to choose from will reflect the contents of the Summer School lectures. The Short Essay must be submitted within three weeks from the end of the Summer School (*i.e.*, by 21 October, 2022).
